'Walk in Their Shoes' supports Open Table Ministry's mission to end homelessness through community. At Open Table Ministry, we help our homeless and unsheltered neighbors by providing basic necessities like food, clothing, and emergency shelter, and by offering care and support throughout the housing navigation process.

A few items of instruction for all walkers:

1. If you have not already registered, register online at www.opentableministry.org.
2. Use the Pledge Form on the next page and an envelope to collect pledges of cash or checks from friends, family, and co-workers.
3. Be sure to obtain their name and pledge amount on the form. Record their address and email address, and indicate if they would like a receipt sent to them.
4. Bring your envelope along with cash and checks to "Registration Check-In" on the day of the walk, at **Southern Boundaries Park (100 Third Fork Road, Durham)** on Saturday, November 5, between 9:30am and 10:00am.
5. If you find that you are unable to come on the day of the Walk and have collected pledges, you can mail your envelope along with pledges (PLEASE DO NOT MAIL CASH) to Open Table Ministry, P.O. Box 51363, Durham, NC 27717.
